Scholarship Application

Deadline- Monday, May 8th to the Extension office
2023 4-H Junior Camp- June 13-16

Application is to be completed by 4-H member and/or parent/guardian and then signed and turned in to the Extension office by the respective 4-H club advisor. Camp is open to all 4-H members (and non 4-H members) who are at least 8 years old and in the third grade to 14 years old by the first day of camp. Youth who are 14 as of January 1, 2023 are not eligible to attend camp. Scholarships are provided by the Seneca County Jr. Fair Foundation. 4-H members are eligible for scholarships. Scholarships turned in after the deadline will not be considered. There will only be partial camp scholarships granted; at the most, up to 50% of the cost of camp. The cost of 4-H camp will be \$185 for 4-H members. 4-H members from low socio-economic homes, one parent families, and large families with multiple children wishing to attend camp will be given priority consideration in the scholarship selection process. If a 4-H member is granted a scholarship, they must write a thank you card to our sponsor and turn it in to the Extension office before they can receive their scholarship amount. Information shared on this form is kept confidential.

A \$90.00 payment will hold a place on the camper list until scholarships are given consideration. Applicants will be notified after the scholarship deadline with the remaining balance due by May 22, 2023.
